IT MAY NOT BE ALTERED OR MODIFIED EXCEPT BY A SEPARATE AGREEMENT SIGNED BY CFI. ANY INCONSISTENT TERMS IN ANY OTHER DOCUMENT ARE INVALID, WHETHER OR NOT THE OTHER DOCUMENT IS DATED, CREATED, SENT OR RECEIVED BEFORE OR AFTER THIS DOCUMENT. NO OTHER DOCUMENT PURPORTING TO CONTAIN DIFFERENT TERMS WILL BE EFFECTIVE UNLESS SIGNED BY CFI.

1. LICENSE AGREEMENT: I have read and understand and agree to this entire agreement. This agreement is a binding contract between Centrifugal Force, Inc. d/b/a Wise Choice Software (CFI) and you, the purchaser (LICENSEE). For purposes of this agreement, "LICENSEE" means the person or company to whom the SOFTWARE has been provided by CFI and all successors, assigns, agents, representatives, employees, officers, directors, partners, members and managing agents of the foregoing. RightClick® software and all of its components (SOFTWARE) are provided "AS IS." LICENSEE has had ample opportunity to examine, use, test and determine usability of SOFTWARE in LICENSEE'S organization and on LICENSEE'S own computer equipment prior to entering into this agreement. LICENSEE has come to its own conclusion regarding the usability and suitability of SOFTWARE. For purposes of this agreement, "SOFTWARE" means (a) all of the contents of the files, disk(s), CD-ROM(s) or other media which the SOFTWARE is provided, including but not limited to (i) CFI or third party computer information or software; (ii) digital images, stock photographs, clip art, sounds or other artistic

works; (iii) related explanatory written materials or files; (iv) fonts; (v) source code files and web page files included with and created by SOFTWARE; (vi) executable program files that run on a local computer, server computer and website hosting server and (b) upgrades, modified versions, updates, customizations and additions to the SOFTWARE, if any, licensed to LICENSEE by CFI.

2. Unless otherwise indicated on the face of this agreement, this agreement is limited to the license to use SOFTWARE on a single computer file server or a single computer if LICENSEE employs a single stand-alone workstation environment. No copy of the SOFTWARE may be kept for back-up or archival purposes. Training, support (telephone or otherwise), assistance, help, customizations, resolutions to problems, installation and all types of service are provided: (a) as outlined in this agreement; or (b) with the purchase of a separate Annual Telephone Support Contract; or (c) on a pay per incident basis in accordance with our practices and at the rates in effect at the time the service is provided. The LICENSEE will not receive training, support (telephone or otherwise), assistance, help, customizations, resolutions to problems, installation or any other service free of charge. All costs related to hardware (equipment), network connections, network software, operating system software and all costs related to installation, maintenance and training on any equipment and software required to use SOFTWARE are the exclusive responsibility of the LICENSEE. This agreement licenses only the use of the particular SOFTWARE specified on the face of this document as it exists as of the date set forth on the

face of this agreement. LICENSEE acknowledges that the foregoing license extends only to LICENSEE's use of the features and functionality of the SOFTWARE as described in the SOFTWARE documentation for this product, and LICENSEE agrees not to reconfigure or modify the SOFTWARE in order to enable other features or functionality. The SOFTWARE is the intellectual property of CFI; its structure, organization and source code are valuable trade secrets and confidential information of CFI. LICENSEE may not: (a) reverse engineer, de-compile, or disassemble the software or allow others to do so; (b) modify or create derivative works based upon the SOFTWARE in whole or in part; (c) distribute copies of the SOFTWARE; (d) remove any proprietary or copyright notices or labels on the SOFTWARE; or (e) assign, resell, lease, rent, transfer, convey, license, sublicense, or otherwise transfer rights to the SOFTWARE to any affiliate, subsidiary or any other third party. Any use in violation of this section shall be void and shall immediately terminate LICENSEE's license to the SOFTWARE and shall entitle CFI to collect any damages it has incurred. In the event of a breach of this agreement by LICENSEE, LICENSEE acknowledges and agrees that CFI shall be entitled to injunctive relief as well as other applicable remedies at law or in equity against LICENSEE. CFI reserves the right to modify, improve or correct the SOFTWARE or to substitute new or additional SOFTWARE and/or discontinue the sale or support of the SOFTWARE licensed by this agreement. LICENSEE is not entitled to receive any such modified, improved, corrected, new or additional SOFTWARE, except as the same may be explicitly provided in this agreement or as may be agreed in a separate written agreement.

3. All SOFTWARE for which payment is made under this Agreement, including SOFTWARE design, architecture, structure, appearance, "look and feel," source codes and object codes, is owned by CFI and is copyrighted and licensed, not sold or assigned. CFI grants LICENSEE non-exclusive, non-transferable, evergreen license to use the SOFTWARE for which the license fee has been paid in advance. Any SOFTWARE licensed under this Agreement, including all SOFTWARE components and all functions, are and remain the copyrighted intellectual property of CFI, portions copyrighted by Pepperwhite, Wise Choice Software® and RightClick® are registered trademarks of CFI. SOFTWARE is protected by copyright law and international treaties. Unauthorized reproduction or distribution of SOFTWARE or any portion of it, will result in severe civil and criminal penalties. LICENSEE acknowledges that the SOFTWARE is subject to U.S. export jurisdiction. LICENSEE agrees to comply with all applicable international and national laws that apply, including the U.S. Export Administration Regulations, as well as end-user, end-use and destination restrictions issued by the U.S. and other governments.

4. LICENSEE represents, warrants and covenants: (a) LICENSEE is a business familiar with the use of the SOFTWARE in question; (b) LICENSEE will use the SOFTWARE for its business purposes only and will not use the SOFTWARE for any personal or unrelated purpose; (c) LICENSEE is not a "consumer" of any product or service licensed or provided by CFI as that term is used or understood in connection with any federal or state law for the protection of consumers, and agrees that the SOFTWARE is to be used exclusively for business and commercial purposes; (d) LICENSEE has reviewed the hardware and SOFTWARE requirements.

5. CFI has made no representations, warranties or promises except as specifically set forth in this agreement. THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE DESCRIPTION ON THE FACE HEREOF.

6. No refunds are allowed, regardless of reason, on all SOFTWARE and all services. Complete payment is due with this agreement. All invoices are due upon receipt. All services are provided between 9AM and 5PM E.S.T., Monday through Friday, excluding national holidays. All services are timed in fifteen (15) minute increments and rounded up. Pricing and fees are subject to change without notice. Invoices delinquent for thirty (30) days or greater will bear interest from the date of the invoice at the rate of eighteen percent (18%) per year, or at the highest legal rate permissible by law if it is lower than eighteen percent (18%). All costs of collection, including collection agency and attorneys' fees and other litigation costs, will be paid or reimbursed by LICENSEE. Amounts paid pursuant to this agreement will be applied to reduce the balance due under any invoice for goods or services provided or contracted to be provided by CFI, or any other division of CFI, which is delinquent for more than thirty (30) days. CFI reserves the right to suspend providing any goods or services, including but not limited to telephone support and SOFTWARE updates, pursuant to this agreement and any other agreement between CFI until all amounts due to CFI have been paid in full.

7. LIMITED WARRANTY: CFI warrants that SOFTWARE will perform substantially in accordance with the online documentation in effect as of the date of this agreement for a period of ninety (90) days from the date hereof. In the event of a claim under this warranty, LICENSEE's sole remedy is to receive repair or replacement of the SOFTWARE that does not meet this Limited Warranty. CFI's and its suppliers' entire liability and LICENSEE'S exclusive remedy shall be as specified in this paragraph. This Limited Warranty is void if failure of SOFTWARE has resulted from accident, tampering, disassembly, alteration, abuse, or misapplication, or use of any electronic database file with another software product. Any replacement SOFTWARE will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer. This warranty gives LICENSEE specific legal rights, and LICENSEE may also have other rights, which vary from jurisdiction to jurisdiction.

8. CFI AND ITS SUPPLIERS DISCLAIM ALL OTHER WARRANTIES, REPRESENTATIONS, PROMISES AND GUARANTEES, EXPRESS OR IMPLIED, STATUTORY OR OTHERWISE, ON THE SOFTWARE, MEDIA, DOCUMENTATION OR RELATED TECHNICAL SUPPORT INCLUDING, WITHOUT LIMITATION THE IMPLIED WARRANTIES OF MERCHANTABILITY, PERFORMANCE AND FITNESS FOR A PARTICULAR PURPOSE. CFI WILL NOT BE LIABLE FOR DIRECT OR CONSEQUENTIAL DAMAGES RESULTING FROM ANY BUG, ERROR, OMISSION, DEFECT, DEFICIENCY OR NONCONFORMITY IN ANY SOFTWARE. AS A RESULT, THE SOFTWARE AND DOCUMENTATION IS LICENSED "AS IS", AND THE LICENSEE ASSUMES THE ENTIRE RISK AS TO ITS QUALITY AND PERFORMANCE.

9. IN NO EVENT WILL CFI OR ITS SUPPLIERS BE LIABLE FOR INDIRECT, SPECIAL, INCIDENTAL, CONTINGENT, CONSEQUENTIAL OR SIMILAR DAMAGES OF ANY KIND RESULTING FROM ANY DEFECT IN THE SOFTWARE OR DOCUMENTATION, INCLUDING, WITHOUT LIMITATION, ANY LOST PROFITS OR SAVINGS, DAMAGES FROM BUSINESS INTERRUPTION, LOSS OF OR TO DATA, COMPUTER PROGRAMS, BUSINESS, DOWNTIME, GOODWILL, DAMAGE TO OR REPLACEMENT OF EQUIPMENT OR PROPERTY, OR ANY COSTS OF RECOVERING, REPROGRAMMING OR

REPRODUCING ANY PROGRAM OR DATA USED IN CONJUNCTION WITH THE PRODUCTS, EVEN IF CFI, ITS SUPPLIERS OR ANYONE ELSE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. LICENSEE AGREES THAT CFI'S AND ITS SUPPLIERS' LIABILITY ARISING OUT OF CONTRACT, NEGLIGENCE, STRICT LIABILITY IN TORT, WARRANTY, OR ANY OTHER CAUSE OF ACTION, SHALL NOT EXCEED THE AMOUNT PAID BY LICENSEE FOR THIS PRODUCT. ANY WRITTEN OR ORAL INFORMATION OR ADVICE GIVEN BY CFI DEALERS, DISTRIBUTORS, AGENTS OR EMPLOYEES WILL IN NO WAY INCREASE THE SCOPE OF THIS WARRANTY, NOR MAY LICENSEE RELY ON ANY SUCH WRITTEN OR ORAL COMMUNICATION.

10. This agreement is governed by and shall be construed and enforced in accordance with the law of the State of New York applicable to contracts made and to be performed therein, without regard to choice of law provisions. THE PARTIES HEREBY EXPRESSLY WAIVE ANY JURISDICTION TO WHICH THEY MAY BE ENTITLED BY VIRTUE OF DOMICILE OR OTHERWISE. LICENSEE AND CFI HEREBY AGREE AND CONSENT TO EXCLUSIVE JURISDICTION AND EXCLUSIVE VENUE IN THE STATE AND FEDERAL COURTS OF NEW YORK COUNTY, NEW YORK, AND WAIVE ALL OBJECTIONS THERETO. Any dispute between the parties, whether arising under this agreement or otherwise, shall be resolved only in the federal or state courts of competent jurisdiction located in New York County, New York, and in no other forum. The parties consent to personal jurisdiction and venue in those courts and represent that those courts are convenient fora for the resolution of any such dispute. Process in any action brought in any such court may be served in any manner prescribed by law or order of the court or, in the alternative, by certified mail, return receipt requested, addressed to the party to be served at the address set forth on the face of this agreement or at such other address specified in a notice mailed by certified mail and addressed to the party to be served at the address set forth on the face of this agreement or at which the party is customarily addressed for services under this agreement.

11. The facsimile of this signed agreement is binding. The LICENSEE agrees to be bound by the terms of the Usage Agreement and the Download/Upload Agreement, which is consented to with each and every use of SOFTWARE. If LICENSEE accepts this contract and all of its provisions, it shall supersede and replace any and all prior agreements, memoranda, contracts, understandings, practices and customs which may have existed between us in the past. This document represents the entire agreement, and all negotiations, discussions, conversations and drafts which may have led up to the formalization of this agreement are superseded by this document, and have no further force and effect. LICENSEE's obligations under this agreement shall survive any termination of this agreement. In the event of invalidity of any provision of this agreement, the parties agree that such invalidity shall not affect the validity of the remaining portions of this agreement. The products offered and services we would perform under this agreement are limited only to those specifically set forth herein. When accepted, this agreement may not be terminated, modified, amended or altered without an agreement in writing signed by CFI. From time to time, CFI and LICENSEE may enter into additional agreements to perform additional services or for additional products and it is agreed by both parties that this agreement will remain in effect and not be voided, superseded or novated by future agreements or contracts unless it is explicitly provided.

12. In any litigation arising from or relating to this agreement, LICENSEE agrees to pay, on demand, all costs and expenses of CFI, including, without limitation, reasonable attorney's fees related to any suit, expenses such as expert witness fees and technology forensics fees, mediation or arbitration proceeding, out of court payment agreement, trial, appeal, bankruptcy proceedings or other proceeding, in such amount as may be determined reasonable by an arbitrator or court, as applicable.

13. For and in consideration of the SOFTWARE provided by CFI to LICENSEE, LICENSEE does hereby RELEASE AND DISCHARGE CFI and its successors, assigns, officers, managers, directors, shareholders, members, employees, agents, attorneys, representatives, parent corporations, subsidiaries, and affiliates (collectively referred to as "Affiliates"), jointly and severally from any and all claims, counterclaims, demands, damages, debts, agreements, covenants, suits, contracts, obligations, liabilities, accounts, offsets, rights, actions and causes of action of any nature whatsoever, including, without limitation all claims, demands, and causes of action for loss of use, loss of data, loss of profits, and contribution and indemnity, whether arising at law or in equity (including without limitation, claims of fraud, duress, mistake, tortious interference, usury, violation of any state deceptive trade practices act), whether presently possessed or possessed in the future, whether known or unknown, whether liability be direct or indirect, liquidated or unliquidated, whether presently accrued or to accrue hereafter, whether absolute or contingent, foreseen or unforeseen, and whether or not heretofore asserted, for or because of or as a result of any act, omission, communication, transaction, occurrence, representation, promise, damage, breach of contract, fraud, violation of any statute or law, commission of any tort, or any other matter whatsoever or thing being done, omitted or suffered to be done by CFI or its Affiliates, IN SO FAR AS THE SAME ARISES OUT OF OR RELATES TO THE SOFTWARE PROVIDED BY CFI TO LICENSEE. Excepted from the foregoing release is any limited warranty claim made by LICENSEE pursuant to the limited warranty given by CFI hereunder in paragraph 7.

14. LICENSEE shall indemnify, defend and hold CFI and its Affiliates harmless from and against any and all claims, demands, suits, losses, damages, assessments, fines, penalties, costs or other expenses (including reasonable attorneys' fees and court costs) sought by third parties against CFI arising from or in any way related to any of the SOFTWARE provided to LICENSEE by CFI. Upon demand by CFI, LICENSEE shall diligently defend CFI against any of the foregoing all at LICENSEE's own cost and expense and by counsel to be approved by CFI in the exercise of its reasonable judgment. In the alternative, at any time CFI may elect to conduct its own defense through counsel selected by CFI and at the reasonable cost and expense of LICENSEE.

15. This agreement shall terminate automatically if LICENSEE fails to comply with the terms of this agreement. No notice shall be required from CFI to effectuate such termination. LICENSEE may also terminate this agreement at any time by notifying CFI in writing of termination. Upon termination LICENSEE must uninstall and destroy all of the SOFTWARE and provide reasonable evidence thereof to CFI.

All rights not expressly granted in this agreement are reserved by CFI.
